About LCT

- An intuitive tool for resource license clearance.
- Automates the clearance of rights for **derivative** works.
- Facilitates FAIRness and the condition of **Reusability**.
- Mitigates legal uncertainty and diminishes costs in the clearance of licensing issues.

LCT Functionality

- Wizard based form to guide you through the required fields
- Two distinct workflows for derivative works
 - Resource driven or License driven
- Available for registered and guest users
- Custom pdf report generation with all clearance information
 - Personal & Ethics Information included if available
- Clearance history for registered users

Assume that you are a designer, and you are requested to create the logo of a company to be used in their website and social media.

Requirement

The logo should contain both a descriptive image and some text. Before providing the company with the new logo you need to follow some steps to appropriately license the new logo.

Yes! Because you used an existing open-source icon and an existing font for the text.

How can you clear the license of your work?

Use the “Resource Driven” workflow of LCT

How should you proceed?

1. Provide the General Information about the logo
2. Add the required information for the used **icon** in the "Licensing In" section including its **license!**
3. Add the required information for the used **font** by adding an additional resource to the "Licensing In" section. Do not forget its **license!**
4. Go to the "Licensing Out" section and select one of the **compatible licenses!**

Add any information concerning the IPR and the Personal data of your new logo
